RESEARCH EXPERIENCE

Previous

2013-2015: My master's research dissertation is a comparative analysis of public policies of financial inclusion and South-South cooperation between Brazil and Venezuela (2009-14). I spent three months in Caracas interviewing key actors within government and institutions. My dissertation provides new insights into financial inclusion policy and public banks and develops a solid framework for their comparative analysis in a Global South context. The theoretical approach consists of the theory of the imperfect market and the role of public banks in economic development.

2014: research coordination of two-month fieldwork within the project "*Evaluating Banking Agents: The Case of Brazilian Banking Correspondents*" funded by the Getúlio Vargas Foundation. The research aimed to apply and validate the framework previously developed within the project "Formulation of impact indicators for microfinance", to understand the impact of ICT and public bank services on financial inclusion. The assessment of the policy was based on a bottom-up methodology.

Current

2018-2023: My **doctoral research** on *Chinese insertion in the World Economy: An analysis from the Political Economy perspective of the regulation policy for inward foreign direct investments* is funded by the Brazilian Ministry of Education. By adopting an approach of international political economy and business theory, it provides a deeper and more critical understanding of the role of the State, Transnational Corporations and Foreign Direct Investment in the development of the People's Republic of China.

March 2023: I was invited to participate as the Brazilian Delegate for the **Seminar on Chinese** - **Latin American Cooperation on 'Belt and Road' Joint Construction** (*Cooperación entre China y América Latina en Construcción Conjunta de "la Franja y la Ruta"*) on 09-22 Mar 2023 in Beijing, China. Future

In the next few years, I plan to extend my research approach to a **comparative study** of Foreign

Direct Investment, Economic Development, Transnational Corporations, and the role of the State in the Global South, focusing on Latin America and China. Besides this, I aim to develop a research agenda on EU public policies concerning Chinese investments overseas, and the reorganization of the local production chains.
